Hereinafter referred to as **the Submitter**, with the following content:

- §1. The Submitter confirms that it has read and accepts the General Terms and Conditions of Sale of INTERSTAL S.A. available at [www.intertsal.pl](http://www.intertsal.pl).
- §2. INTERSTAL S.A. accepts for safekeeping and undertakes to keep in a non-defective condition the goods listed in the appendix to the contract, which were ordered by the Storer but were not collected by the Submitter on the agreed date.
- §3. The Submitter has been given the opportunity to inspect the object of storage and has no objection to its condition, quantity or manner of storage.
- §4. The place of storage is the warehouse of INTERSTAL S.A. at its production plant in Bytom at 1 Fabryczna Street.
- §5.1. In return for storing the object of storage, the Submitter undertakes to pay INTERSTAL S.A. the remuneration in accordance with the General Terms and Conditions of Sale of INTERSTAL S.A. available at [www.interstal.pl](http://www.interstal.pl) (1% of the net value of the unclaimed goods for each day of storage, not less than PLN 100 net per day), i.e. .... PLN net. VAT will be added to the net amount at the applicable rate.
- 5.2. Payment of the storage remuneration will be made to the bank account and by the date indicated on the VAT invoice.
- 5.3. INTERSTAL S.A. shall, at its option, either issue a single summary storage invoice or issue partial VAT invoices for past storage periods.
- §6. Any disputes concerning the storage shall be settled by the common court having jurisdiction over INTERSTAL S.A.
- §7. Any amendment to this agreement must be made in writing under pain of nullity.
- §8. In matters not covered by this agreement, the provisions of the Civil Code and the General Terms and Conditions of Sale of INTERSTAL S.A. shall apply.
